Participant enters into this Release and Waiver, and Assumption of Risk, for Participant and for any and all of Participant's minor children who Participant permits to use the facilities, programs on the premises or off premises including any sponsored center event or virtual program including exercise programs, equipment, or materials provided by The Young Men's and Young Women's Hebrew Association (dba The 92nd Street Y or 92NY), as defined below, with or without supervision. In consideration of being permitted to enter upon, participate in and use the facilities, programs on the premises or off premises including any sponsored center event or virtual program including exercise programs, equipment, or materials of or offered by the 92nd Street Y, Active Wellness LLC, and each of their agents, owners, directors, officers, employees, partners, independent contractors, volunteers, and all other persons acting in any capacity on their behalf (collectively, the "Center Parties"), I, on behalf of myself, my guests, children, heirs, executors, administrators, successors and assigns, hereby: as defined below, with or without supervision.

- 1. Acknowledge, understand and appreciate that my entry upon and/or use of the facilities, equipment, services and activities of or offered by the Center Parties entails significant risks, both known and unknown, including, without limitation, the possibility of physical or emotional injury, paralysis, death, other serious or catastrophic personal injuries, and loss or damage to personal property.

- **3.** Expressly and voluntarily release and forever discharge each of the Center Parties from any and all claims, demands, causes of action or liability for any loss, damages, injuries or death that I may suffer as a result of my entry upon, participation in or use of the facilities, equipment, services or activities of or offered by the Center Parties, whether the same arises out of or results from any act, omission or conduct of one or more of the Center Parties, negligent or otherwise.

action, or liability for any loss, damages, injuries or death suffered by any other person in connection with my entry upon, participation in or use of the facilities, equipment, services or activities of or offered by the Center Parties, whether the same arises out of or results from any act, omission or conduct of one of more of the Center Parties, negligent or otherwise. - **5.** I expressly understand that 92NY has implemented strict and thorough protocols and procedures designed and intended to thwart the spread of the novel coronavirus (COVID-19), which have been described to me and which I agree, and agree to cause my child(ren), to follow, and I further understand and agree that, notwithstanding its efforts, as an institution open to the public 92NY cannot guarantee that it, or its other patrons, are entirely free from the coronavirus and thus there is an unavoidable risk of exposure to COVID-19 or other infectious diseases by entering into and/or use of the 92NY facilities, and transportation provided to and from them.
