

Hudson Valley Fall Art Excursion with Riva Blumenfeld

October 8 – 10, 2025 Hudson Valley, NY



Join the 92NY Art Center for a three-day journey through the Hudson Valley during the early days of fall, when the region begins to shift into its most colorful season. This intimate art-focused tour offers private access to world-class museums, contemporary galleries, and artist studios—all set against the backdrop of crisp air, golden light, and the first signs of autumnal change.

Our home base will be The Wick, a beautifully restored boutique hotel located in the heart of Hudson, NY. Upon arrival, we'll explore some of the city's most exciting galleries before gathering for a **welcome dinner and drinks**—an opportunity to get to know your fellow travelers and toast the vibrant days ahead.

The following morning, our **private shuttle** will take us to **Olana**, the former home of Hudson River School painter Frederic Edwin Church. With sweeping views of the Catskills and hints of fall color unfolding across the landscape, this historic estate includes a uniquely designed mansion and expansive grounds. We'll enjoy a private, guide-led tour of both the house, art collection, and property, followed by a box lunch outdoors surrounded by natural beauty.

Next, we'll head to the Hessel Museum at Bard College for private tours of two major fall exhibitions. Stan Douglas: Ghostlight presents cinematic, large-scale photo works exploring performance and politics, while All Manner of Experiments: Legacies of the Baghdad Group for Modern Art examines the groundbreaking contributions of Iraqi modernists and their global impact—an extraordinary glimpse into an underrecognized but influential art movement. From there, we'll continue to a renowned local artist's studio for an exclusive behind-the-scenes visit and conversation.



On our final day, we'll begin with a visit to Storm King Art

Center, a world-renowned sculpture park set across 500 acres of fields and woodlands. As the landscape begins its seasonal transformation, we'll explore two special exhibitions, *Kevin Beasley: The Willing*, featuring monumental sculptural installations that center Black cultural histories through sound and material, and *Sonia Gomes: In the Garden*

of Forking Paths, where the Brazilian artist's vibrant textile-based works engage with themes of memory, resilience, and transformation.

From there, we'll travel to **DIA Beacon** for a private, guide-led tour. Housed in a former Nabisco box-printing factory, DIA's singular collection includes iconic works by artists such as **Agnes Martin**, **Donald Judd**, **Richard Serra**, **Louise Bourgeois**, **and Dan Flavin**, among many others. After exploring the galleries, we'll enjoy a box lunch on-site before continuing our journey.

We'll conclude our tour with a private visit to Magazzino Italian Art Foundation in Cold Spring. Dedicated to postwar and contemporary Italian art, Magazzino offers a striking architectural space to experience works by major artists including Michelangelo Pistoletto, Marisa Merz, and Alighiero Boetti. We'll raise a glass during a farewell toast before being dropped at the Cold Spring train station for easy return travel to New York City.

We recommend participants travel by train to Hudson, NY to meet the group at the start of the tour. Transportation throughout the trip, all site admissions, private tours, and meals as listed will be included.

Traveling with you is 92NY Art Center educator Riva Blumenfeld, who has 40 years' experience as a gallery director/owner, art advisor for collectors and arts educator at NYC's top museums. Riva will help you unpack the artists' vision and process and understand the fascinating history of this destination. In addition, you'll meet local experts and guides who will give you an inside look into these unique collections.

You'll be on the go every day on this tour. The group will travel to sites via private shuttle or we'll be walking where you should expect uneven paths, stairs, and inclines. Participants can expect to be standing or walking for 1-2 hours at a time while on excursions. Tour start and end times will be announced at the beginning of the trip. Participants are responsible for arriving to the meeting locations on time. Your tour will begin at The Wick Hotel (a 2-minute walk away from the Hudson train station) and end with a transfer to the Cold Spring train station.
